Responsibilities:

1. Maintain the record of all child/adolescents enrolled, recommended and rejected in the project
2. Analyze the data and prepare reports based on online entry
3. Follow up and ensure appropriate management of each of the cases
4. Liaison with the parents.
5. Scrutiny of applications received via Mittayi Software and submitting the list of application before Mittayi State Technical Committee.
6. Co-ordination of the functioning of all Mittayi Clinics.
7. Assist and ensure smooth and proper delivery of services and medicines in coordination with KMSCL to Mittayi clinic associated with Medical College Hospitals and satellite centers.

General Terms & Conditions :

1. The applications that are not complete in all respect will not be considered for Short listing and no further communication will be done in this regard.
2. All communication including the interview call letter from the Kerala Social Security Mission (KSSM) side will only be through e-mail. The applicants should have a valid e-mail id. The candidates with the prescribed

qualification only need to apply for the above position. Ineligible applications will be rejected, and no further communication will be done in this regard.

3. Recruitment is for immediate requirement. The selection will be based on Qualification, Experience (if any), and performance in the written test / interview or both, however applicable. Ineligible applicants shall be avoided at any stage of the recruitment.

4. The selected candidate needs to enter into a contract agreement with the Kerala Social Security Mission (KSSM). The selected candidate will be appointed on a contract basis with consolidated pay initially for a period of One year from the date of joining. Based on the performance and integrity of the candidate, the contract appointment may extend further as per the requirement of Kerala Social Security Mission (KSSM).

5. Claims in respect of qualifications or experience (if any) etc. should be supported by self-attested copies of relevant documents in the application; fail to do so will lead to rejection of the application. Offer letter, appointment order, salary slip etc. will not be considered as proof of experience. Candidates are required to produce the originals at the time of interview or when demanded by KSSM.
